The entry form appears at the bottom of this guideline

- Entries may not be a copy of any previously published materials. Additionally, winning image may not be submitted to other design competitions or contests.
- Entries should depict the spirit of the Ennis parade theme: **Ropin’ & Reelin’** You are not required to include any of these elements and preference will not be given either way.
- Two options for submitting:
 - Entries may be mounted on a firm backing (e.g., foam core, mat board, solid white background preferred) and dropped off at Ennis Chamber office
 - Digital submissions are acceptable for all mediums of art and should be emailed to info@ennischamber.com
- \$10 entry fee required with entry form; artist may submit up to two original entries.
 - Entries must have a completed and signed entry form securely attached to the back.
 - Image size of all drop-off entries must be a minimum of 6” x 6” or 6” x 8”, vertical and horizontal. Entries with smaller dimensions will NOT be considered
 - Drop-off submissions must be accompanied by a check for \$10 payable to Ennis Chamber of Commerce.
 - If submitting via email, attach a copy of the entry form and notate “check in mail”.
 - Include the following information:
 - Your Name
 - Attach up to 2 images as instructed below
 - JPEG files, 1024 pixels on the longest side at 72DPI, 2MB or less
 - File Names: firstname_lastname1.jpg; firstname_lastname2.jpg
 - Make check payable to Ennis Chamber of Commerce and mail to PO Box 291, Ennis, MT 59729. Include a copy of submission form with the check.
- NO identification of the artist/entrant of any kind may be incorporated into the artwork or appear on the front of the submission.
- A parent or guardian must sign the entry form for any entrants under age 18. A teacher’s signature is not sufficient.

Ennis Chamber of Commerce

- Ennis Chamber of Commerce and its officers and agents are not responsible for the loss or damage to entries, although reasonable care will be taken to ensure that all entries are safely handled and displayed.
- All levels of expertise are encouraged to enter.
- Guidelines:
 - Submissions should be an illustration of your choice of media including computer-generated artwork.
 - If the artwork is computer generated, the contest winner must provide an electronic file of the artwork – either Adobe Illustrator (.ai) or Photoshop (.psd) document vector format – separated and layered.
 - The use of stock clip art is not permitted, and all fonts used must be available for free for commercial use without payment of royalties.
 - Submissions should not include the use of the Ennis Chamber logo.
 - Artist retains ownership and copyright of original design.
 - The Ennis Chamber of Commerce reserves the right to modify or adapt the winning design without further consent from or compensation to winning artist. The Ennis Chamber of Commerce will retain ownership of the final design.
- Notification
 - The Ennis Chamber of Commerce directors will jury the entries at a meeting in May.
 - The winning artists will be notified by May 16, 2017.
 - Winner will be announced on our website and Facebook after notification to the winner.
 - Non-winning artists will not be notified directly. **Any artwork not picked up by June 30, 2017 will be discarded.**
